

The **President's report** reviewed the many trials that the club has sponsored during 2024. The club did not make money on the trials, but neither was money lost. It was a good year.

There was no report from the Vice president. The Treasurer distributed the Profit and Loss statement for January-December as well as individual reports for each of the trials held during the year. Discussion of successes and things to change followed. Sue moved and Rhonda seconded that the treasurer's report be accepted.

The **Secretary** reminded members that a new roster will soon be prepared based on those who have paid dues by March 15. The roster will be emailed to all members for any needed revisions, before it becomes final.

BDOC had another productive and fun year in 2024. For the first time in many years, BDOC decided to not hold our UKC nosework trial in February. That turned out to be a good decision as once again, it was cold and snowy for that weekend in 2024. By not holding this event, we now have five months between our last event of the year and our first event of the next year, giving our small and dedicated group of volunteers a nice long break. Our first event of the year was AKC Obedience and Rally on March 30, 31, and April 1st. This was a fun trial that was well attended. An exciting outcome of this trial was Gerianne's Rayna finishing her Obedience Trial Championship on April Fool's Day! There is probably a joke there, but we will leave it unsaid! Obedience was followed two weeks later by our first herding trial of the year, featuring two ranch trials on Friday and four regular herding trials over the weekend. Although both of these events lost money, that loss was more than made up for by an AKC Scent Work trial the last weekend of April. April is a busy month for our club! June featured a UKC nosework/ obedience/ rally trial early in the month and a CPE Scent Sports trial later in the month. Both events showed a profit, with the CPE trials barely breaking even. The club voted to again discontinue holding CPE Scent Sports. We have difficulty getting our regular volunteers for this event, and it was decided to let the event go for 2025. We then had a break until the next AKC Obedience/Rally weekend in early August. We had a nice, healthy entry, and again many titles and qualifying scores were earned. Two weeks later was our August AKC Scent Work trial. The format of utilizing three judges and offering all of the regular elements plus Detective each day is very popular with exhibitors, and we have expanded that to include our April AKC Scent Work trials in 2025. We held our second weekend of AKC Herding Trials in September, which included ranch trials on Friday. For some reason the herding entry was way down in September. We are going to add American Herding Breed Association trials on

Friday to this weekend in 2025 to hopefully increase the entry on the weekend, along with offering more herding opportunities to local herding enthusiasts. In late October, we held our fall tworing AKC obedience and rally trial at the Companion Dog Club, which features two trials on Saturday and one on Sunday. Although Saturday is a very long day for exhibitors and judges, this format is very popular with the exhibitors, as they only have to purchase two nights in a motel for three trials. Gerianne's Rayna finished her THIRD AKC Championship at a BDOC event at these trials, Rally Obedience Champion! In early November we held our last event of the year, AKC Scent Work, and again the entry was large and enthusiastic, and we made a nice profit. Our club broke even in 2024, earning a small profit overall of \$64.15. BDOC continues to provide the local dog community with several awesome events. We had some fun club meetings in 2024. March featured our 2023 Awards Banquet. We held this event at Christ The King Lutheran Church in Bellevue, with the food catered by Hy-Vee. Everybody enjoyed the good food and the nice quiet place to hold our banquet. In April AKC Fetch Judge and BDOC Board Member Rhonda Pratt presented a very interesting talk and demo on the new AKC Fetch program, and then several club members enjoyed trying out fetch. In July we held our meeting at the Pizza Ranch, and in September we combined tarping for the herding trial with a zoom and inperson meeting at Gerianne's, including obedience training time for anyone who wanted it. Our Christmas party in December featured wonderful food and our annual stealing gift exchange. Much fun was always had by all. Our treasury remains very healthy. That said, some event entry fees may have to be raised going forward given the higher cost of just about everything, including the AKC possibly raising event fees at some point. We will strive to keep the entry cost to our exhibitors as low as we can. We will continue on with our events as long as our health and finances permit. Thanks to all of you for allowing me to be your president for so many years. I consider all of you good friends, and I very much enjoy the fun we have putting on our events.
